TENDER CONDITIONS

SALE OF TELIKOM'S MOTOR VEHICLES

- 1. Subject to BOS approval Telikom's motor vehicles shall be disposed off through TENDER on AS IS, WHERE IS basis with sound or unsound mechanical condition and that Telikom shall not entertain any claims to the contrary.**
- 2. Telikom does not bind itself to accept the highest offer of any tender where it is considered the offer is in excessive of the reserve price. On the same token offers below the reserve price shall not be accepted.**
- 3. If no offers reach the reserve price the highest offer only is given the opportunity to match the reserve price. If the reserve is still not achieved Telikom may tender or dispose of the vehicle in any many it sees fit.**
- 4. Tenderers may bid on more than vehicle but no tenderer will be awarded more than one.**
 - 4.1 If more than one vehicle is being tendered for, a separate tender form must be submitted for each vehicle.**
 - 4.2 In this case tenderers must clearly indicate their order of preference, No.1 being their first choice. Failure to do so will mean Telikom will use its discretion in awarding vehicles in its most financial advantageous manner.**
- 5. Telikom Supply & Logistics Department will advise successful tenderers in writing and / or verbally and the successful tenderer must, with seven (7) working days of such advise pay a deposit of 10% of the accepted price. Within a further seven (7) working days the successful tenderer must pay the balance of the accepted price. Telikom will only accept a Bank Cheque for this payment.**
 - 5.1 In the event of such payment deadlines not being met, Telikom may withdraw the vehicle from the sale and;

a) Offer it to the second highest bidder**

b) Dispose it as it see fit and any deposits paid shall be forfeited.

- 6. Successful tenderers must remove the vehicles at their own expense within two (2) working days from receipt of balance payment (refer to clause 5). Telikom will not accept for any damage, safe custody, missing or stolen parts thereafter.**
- 7. Intending tenderers MUST inspect the vehicle/s prior to submitting their bids as the vehicle/s are sold on the basis of AS IS, WHERE IS and WITH FAULTS/DEFECTS (if any). Telikom will not accept any claims after the acceptance.**
